- All entrance fees have been paid.
- All loans with the credit union are current.
- The credit union has not suffered a loss as a result of a charge-off or discharge in bankruptcy of any loans or obligations.

The Nominating Committee will make its selections, and the nominees will be published in the January newsletter. Voting will take place by a special ballot in January. The election results will be announced during the annual meeting day in March 2018.
