International Credit Union Day Celebrates People Helping People



On October 15, 2015, credit unions around the world will celebrate International Credit Union Day (ICU Day).

Since 1948, on the third Thursday of every October, credit unions have celebrated a simple but radical idea – that by working together, people can improve their financial wellbeing. "People helping people," this year's ICU Day theme, is the foundational philosophy of the credit union movement,

going back to the very beginning.

In 1850s Germany, a group of weary workers formed the world's first credit union. Suffering through an economic downturn and tired of loan sharks exploiting them, they banded together to provide affordable credit to each other. Not-for-profit and governed by and for the people who created them, credit unions not only gave working-class people a way to break a cycle of debt that had bled them of any financial gains. It showed them, for the first time, a path to prosperity.

As not-for-profit financial cooperatives, credit unions are governed by their members – one member, one vote. In many countries, credit unions offer people their first true taste of democracy. At its most basic level, a credit union is people pooling their money to provide each other with affordable loans – a credit union is literally people helping people. This is why we celebrate ICU Day at Members Exchange. This simple idea empowers people, wherever they are in the world or life, to take control of their own financial future.

Nominations Now Being Accepted

Members Exchange has two Board positions and one Supervisory Committee position to fill this year. Any member who is interested in serving should send a request of nomination that must include the following information:

Name, Address, Employer, Education, Credit Union Affiliation (# of years), Professional Associations, Community Involvement and, in five sentences or less, why you would like to serve as a volunteer on the Members Exchange Board of Directors or Supervisory Committee.

The completed request should be sent to: Nomination Committee, c/o MECU, P.O. Box 31049, Jackson, MS 39286. The request of nomination must be received by Wednesday, November 25, 2015. Nominees must be members in good standing as defined by the following criteria: All entrance fees have been paid, all loans with the credit union are current and the credit union has not suffered a loss as a result of a charge-off or discharge in bankruptcy of any loans or obligations. The Nominating Committee will make its selections and the nominees will be published in the January newsletter. Voting will take place by a special ballot mailed to the Members Exchange membership in February. The election results will be announced during the Annual Meeting Day in March 2016.

Directors receive no compensation for the time they contribute to the credit union. Volunteerism is a unique feature of credit unions. Without the time and commitment of its unpaid volunteers, the credit union would be just another financial institution. We thank them for their dedication to the success of Members Exchange.

Want your tax refund sooner than later? Ask your tax preparer to direct deposit it into your Members Exchange account this year! It's easy; just provide the following information with your request:

- ► Members Exchange Routing Number: 265377484
- Account Number: List your checking or savings account number. Please note this number MUST be 13 digits. If you're not sure about your correct number, please contact us.

Double check to make sure your information is correct, so that your refund will post promptly. Failure to provide the correct information may result in your ACH being returned to the IRS and research fees being assessed to your account.

When we do not have your current address on file, you may experience these inconveniences:

▶ We will not be able to send you important notifications. Whether it's your new debit card or your monthly statement, if we don't have your correct address, we won't be able to send them

Did you know? Even if you "forward" your mail to your new address when you move, the post office cannot forward your mail from Members Exchange Credit Union. It will be returned, so it's very important to make sure your address is current at the credit union.
